In this regard, I am directed to inform you that this University has no objection for allotment of students to the aforesaid colleges subject to the fulfillment of the following terms conditions of the state Govt./ NCTE and University Rules & Regulations:-

1. समस्त प्रवेश केन्द्रीकृत व्यवस्था के अन्तर्गत महर्षि दयानंद सरस्वती विश्वविद्यालय अजमेर के माध्यम से पीटीईटी परीक्षा में सम्मिलित छात्रों में से मैरिट के आधार पर प्रवेश दिये जायेंगे।
2. महाविद्यालय राज्य सरकार द्वारा निर्धारित शिक्षण शुल्क के अतिरिक्त किसी भी प्रकार की कोई राशि छात्रों से नहीं ली जावेगी। यदि इस संबंध में किसी प्रकार की शिकायत प्राप्त होती है, तो संबंधित महाविद्यालय की मान्यता को तुरन्त प्रभाव से समाप्त कर दिया जायेगा।
3. महाविद्यालय को एनसीटीई एवं राज्य सरकार द्वारा निर्धारित सभी मापदण्डों की पूर्ति करना अत्यावश्यक होगा।
4. महाविद्यालयों द्वारा उपयुक्त योग्यताधारी शिक्षकों की उपलब्धता की सुनिश्चितता की जावेगी।
5. सूची में अंकित महाविद्यालयों द्वारा संस्था सचिव द्वारा एनसीटीई के मापदण्डानुसार भूमि का स्वामित्व, एनसीटीई के मापदण्डानुसार निर्मित भवन तैयार करने का 100/- रुपये के स्टाम्प पर शपथ पत्र प्रस्तुत करने पर ही काउन्सिलिंग में महाविद्यालयों को सम्मिलित किया जायेगा तथा एनसीटीई से परिसर स्थानान्तरित करने की अनुमति प्रस्तुत करने पर ही सत्र 2017-18 का शिक्षण शुल्क संस्था का देय होगा।

**As per University Rules and Regulations, the College will have to follow the following terms & Conditions.**


1. These colleges will have to complete all the requirement/ formalities for running B.Ed./ B.A.-B.Ed./B.Sc.-B.Ed. colleges as per the norms laid down by the NCTE, UGC, State Government and University Affiliation rules.
2. Qualified Principal and faculty is to be appointed as per the NCTE norms and University rules.
3. These Colleges should have Library, Laboratories, Computer Lab and other infrastructure requirement as per the NCTE and University norms.
4. The University Inspection Committee will inspect/reinspect the college and if the proper requirements are not found, the above permission shall be treated as withdrawn.
5. This NOC is purely provisional and subject to the fulfillment of all the conditions laid down by the NCTE, State Government and University Affiliation rules.
6. The University has legal rights to withdraw affiliation of the college any time, if the conditions are not found satisfactory.
7. These colleges if not found proper will have to go through re-inspection and the re-inspection fee will to be deposited by the concerned colleges within a month to complete the deficiencies pointed out to them.
8. All the requirements will have to be completed within one month's time.
